AVAILABILITY, BOOKING AND CONFIRMATIONS

The general availability guidelines for each tour as listed on the details page for that tour are guidelines only and no guarantee of availability. We cannot guarantee a reservation for a tour for a chosen day or time. Your initial booking is a request and as such does not guarantee your reservation. You should not consider your reservation confirmed until receiving a confirmation email. The email address that was used to book the tour will receive a written confirmation by email (or any other method deemed necessary by us) once a reservation has been confirmed. If for any reason the confirmation email is not received, it is your responsibility to contact us to seek confirmation. All tours are offered subject to availability and must be booked according to the booking procedures stated in these Terms and Conditions. Bookings must be made 24 hours prior to the chosen start date. In the case of overbooking, mechanical difficulties, acts of God, equipment availability, illness, weather conditions, or other acts or events outside our control or that of our suppliers. We reserve the right to work with the supplier to make a reasonable substitution on the day of the tour being used. If substitution is not possible, Af Travel Ideas reserve the right to cancel the tour on short notice. If a tour is cancelled by us or one of our suppliers, for any reason, you will be notified as soon as possible in order to book a convenient alternate date for your tour at no additional charge. Notwithstanding anything to the contrary set forth in these Terms and Conditions or otherwise. AF Travel Ideas will not offer refunds or be liable in any way for expenses that you or other Participants incur relating to a Package that has been cancelled by us or one of our suppliers pursuant to this paragraph.

RESERVATIONS AND CANCELLATIONS

Cancellations may not be initiated by a Participant, redeemer, recipient or purchaser. Once your booking request has been initiated, no refunds are possible. Rescheduling is normally possible within certain time constraints as outlined in the availability section of the tour details. No changes including cancellations can be made to a reservation after that time period. Changes to reserved tours prior to the deadline posted may be subject to a fee by us or our suppliers. In such cases, we are not liable for any costs incurred by the Participant(s), redeemer, recipient or purchaser including any travel or other related arrangements.
